Please answer all of the following questions to the best of your ability and provide any relevant supporting documents to include: —

- A. All Court documents of any kind which you have about the case including details of any court deadlines or hearing dates.
- B. All historical documents such as agreements, title deeds, emails, letters from the other parties or their solicitors, photographs, text/WhatsApp messages, and copies of any advice which you have had from your previous solicitors or barristers

#### **QUESTION 1:-**

Have you or any other party started proceedings in any court or tribunal and if so please state the date when the proceedings were started and provide a copy of all court documents relating to same?



# **QUESTION 2:-**

What are the next deadline dates which have been set by the court for a further step to be taken by you or any other party to any proceedings?



# **QUESTION 3:-**

If no legal proceedings have been commenced are you aware of any limitation date or time limit or deadline which is about to expire in relation to the commencement of any claim in any court or tribunal by you or any other party?



# **QUESTION 4:-**

Do you have any legal expenses insurance cover? This is normally contained in your house contents policy and you should make contact with your insurers to see if they can help with the matter about which you are making an enquiry.



### **QUESTION 5:-**

Please provide the names, addresses, e-mail addresses, telephone numbers and details of all persons or companies who might be a party to your dispute or any claim which might be brought in any court or tribunal. Please also provide similar details of any solicitors who may be acting for any of those parties.



# **QUESTION 6:-**

Do any of the persons or companies are any of the persons who might be a party to your dispute or any claim residing or located outside of England and Wales?



# **QUESTION 7:-**

Do you know if any law other than that of England and Wales applies to your dispute or any contract or property with which it is concerned?



# **QUESTION 8:-**

Have any other solicitors or barristers previously advised you and can you please provide us with either (i) a copy of any written advice received from them or (ii) a summary of their advice?



#### **QUESTION 9:-**

Please explain in detail all the facts/issues which relate to your case. Use dates at the start of any section or paragraph to give a chronological summary of your case. The more detail you provide, the less it will cost us to advise you.

The following are examples of how to provide the information to us: -

3 January 2020 – My father passed away having made a will leaving everything to me and my sister. My father instructed a solicitor (name....) to draft the will for him. Before he passed, he discussed his intentions with me and other members of the family on numerous occasions.

10 March 2020 – My brother lodged a Caveat with the Probate Registry and told us that he intended to challenge my father's will.

5 August 2020 – I received a letter from solicitors for my brother, a copy of which is attached.
